REPRODUCTIVE RIGHTS

In April, the ACLU of Utah Foundation joined with the Planned Parenthood Association of Utah to file a lawsuit in federal court to block H.B. 136—the state's 18-week abortion ban. Our legal team quickly secured a preliminary injunction to stop the abortion ban from taking effect—becoming one of eight states to block unconstitutional abortion restrictions from becoming law in 2019.

VOTING RIGHTS

During the 2019 election, we dispatched poll monitors to three voting locations in San Juan County to observe and implement the legal settlement we reached to provide better translation and language assistance for Navajospeaking voters. By being on the ground, our teams were able to **identify and resolve several critical barriers to voting** to ensure a smoother election.

PRIVACY & TECHNOLOGY

During the 2019 Legislative session, the ACLU of Utah worked with lawmakers to pass H.B. 57, the first law in the nation to require law enforcement to obtain a search warrant to access data stored by a third-party, like a shared drive or cloud-based server. Building on that success, our legal and policy teams are working on upcoming legislation to restrict the use of facial recognition scanning and analysis by law enforcement agencies.
